Commander-in-Chief's Comments



COL CLIFFORD D. WAY, JR.

It was an honor to be selected and elected as your 80th Commander-in-Chief of The Military Order of World Wars at our National Convention held in El Paso, Texas, in August. I pledge to follow the words of the Preamble of the Order to the best of my ability. I realize the Order will be going through a transition period with a new Chief of Staff. I hope all the companions who attended the National Convention had an opportunity to meet Brig Gen Art Morrill. To the others who call, be patient and give him time to understand all the workings of our Order. Please work with the staff on any issues you have come up.

My biography was included in this issue, so I don't plan to go over it. You didn't elect a war hero, or a major player in government or industry. However, when assigned a responsibility, I establish goals with the group I'm working with and a commitment from them on how we can accomplish these goals. I have asked the staff elected and appointed to make a special effort this year to turn around our membership losses and improve chapter participation in the local communities. Goals will not be accomplished if you don't get the members to buy in.

I have spent many hours on the Strategic Plan 2015. I have asked for input from Past National Commanders-in-Chief and from the various committee chairmen. I have tried to reflect the suggestions in the current plan.

MY STRATEGIC GOALS:

- **Reinvigorate our Chapters and Regions.** I have asked Vice Commanders and GSOs to make a point to visit all chapters in their area of responsibility. The Chapters are our life blood and we need to help them if requested. I have a goal to reduce the Order's average age by 1% this year and add 150 net new members. That can happen with your help. The key would be the NPDs. Get members involved!
- **Enhance Financial Management.** Focus more on sources of funds and reporting results back to the EXCOM. Then too, asking companions to consider leaving the Order something in their wills and estates plans. For example, we intend to publish a "how to" guide for legacy giving—an important goal.
- **Increase the National and Local Visibility of the Order.** Restructure web site to make it user friendly and appeal to the younger generation with consideration given to having links to a national blog, Facebook, and Twitter. I have appointed an ad hoc committee to work with the National Staff and report back on it at the midwinter EXCOM meeting. It will take some funding.
- **National, Region, and Chapter Communications enhanced.** Chapters need to communicate with members in a timely manner, e.g., monthly newsletters or even phone committee calls and emails. Regions and Chapters should consider a web site or at least an update to chapters every quarter. Back to item one, National officers should be invited to chapters to speak or help and just visit.
- **Inspire the talent we have as speakers or managers.** The chapters across MOWW need to focus on our core strengths in National Security, Youth Leadership, Scouting, ROTC, and Homeland Security and military experience to be available to speak at local community organizations, schools, and memorial services. Good wine doesn't need to be bottled up forever. We need to use it.
- **Natural program evaluation.** As with any business or organization, this Order needs to evaluate its program and goals need to see they meet our current needs. Can we afford it and staff it? Finally, does it fit into our current long range plans? If not, then bite the bullet and drop it.

Look over the Strategic Plan 2015 on the web site. The information presented by different committees indicated goals and plans for the coming five years. Progress in meeting our goals and executing our plans will be reviewed at least twice a year by the EXCOM and you will have a chance to give input if you wish. Note the first letter in each of major goals spells out REIN IN. That is, halt membership and chapter losses. I can't do it alone; it's going to take YOU. Let's continue to strive to make MOWW a premier Veterans Organization in the Country.

Finally, Jackie and I didn't have a week at home before we attended the International Ball on August 13th, hosted by the Greater Kansas City Chapter. It was attended by some 100 officers and spouses from all the "friendly" nations in their formal dress uniforms.

We enjoyed meeting them and hearing about their stay at the Army Command and General Staff College. Some of them would make formidable YLC speakers. I have not put together a full travel schedule yet, but one of my goals would be to visit chapters in all 14 Regions.

I look forward to serving our Order and each of you this year.

80th Commander-In-Chief Col Clifford D Way, Jr.

DALLAS, TEXAS, CHAPTER



CINC COLONEL CLIFFORD D WAY, JR. joined the United States Air Force (USAF) in 1954 and served on active duty until 1959 as a Navigator and Squadron Adjutant with the 96th Air Refueling Squadron (USAF's Strategic Air Command), flying in KC-97 and KC-135 aerial tanker aircraft. From 1959 through 1984 Col Way served in various capacities with the U.S. Air Force Reserve, starting with the 512th Airlift Wing as an Instructor Navigator in C-124s, and later as the Reserve Wing Procurement Officer at Carswell Air Force Base (AFB). He retired from the U.S. Air Force Reserve in 1984.

He also served as the Senior Officer-in-Charge for the City of Dallas Emergency Office with FEMA; and as the Dallas-area Instructor for the National Defense University Course. In the private sector, Col Way was a Manufacturing and Financial Planning Manager at Texas Instruments until his retirement (1959 to 1998).

Col Way has a degree in Industrial Management & Transportation from Syracuse University. He was a member of Scabbard & Blade and is a graduate of the U.S. Army Command and General Staff College, the Air War College and the National Defense University (seminars).

Col Way joined the Military Order of the World Wars (MOWW), Dallas Chapter, in 1979. His MOWW duties have included Dallas Chapter Adjutant, Junior and Senior Vice Commander, and Commander. Col Way has also been the Region VIII Vice Commander, GSO, and Commander. He was the Chairman of the

Ceremony & Parade Committee for the City of Dallas' Veterans' Day activities for several years, the Dallas Chapter YLC and JROTC Coordinator, and a member and the Chairman of the MOWW Chapter Activities Committee. He also served as an Elected General Staff-at-Large National Officer. He was elected MOWW's National Vice Commander-in-Chief and was the Senior National Vice Commander-in-Chief.

His military awards include the Meritorious Service Medal with one oak leaf cluster and the Air Force Commendation Medal, in addition to other unit, crew and service area awards. He received the Outstanding Reserve Officer Award in 1982 from the Mayor of Dallas and the Regional FEMA Director. His MOWW awards include the Patrick Henry Award (Silver), the Outstanding Service Award, the Merit Award Plaque for outstanding service, and the Membership Medal for recruiting 10 members for the Dallas Chapter, in addition to National Citations for Distinguished and Exceptional Service.

He is an Elder in the First Presbyterian Church and the President of the Church Board. For 25 years he was Fund Campaign Leader for the Richardson YMCA.

Col Way, and his wife, Jackie, have been married for 53 years. They have three married children (all university graduates) eight grandchildren (four in college) and four grandchildren who all attended YLCs. Their son is a hereditary member of the Order.





CAPT RUSSELL R. VOWINKEL

Senior Vice Commander-in-Chief

SENIOR VCINC CAPTAIN RUSSELL R. "RUSS" VOWINKEL was born and raised in Buffalo, New York. He was commissioned as an Ensign in the US Navy in 1962 after completing Aviation Officer Candidate School in Pensacola, Florida. Captain Vowinkel served on active duty from 1962-1967 and served in the Viet Nam War Theater of Operations as a Naval Flight Officer during a period of this time. VCINC LIEUTENANT COLONEL GARY O. ENGEN joined MOWW as a companion with the Augusta Chapter in 1994. He has since served as Chairman of several chapter committees, including their ROTC and Massing of Colors Committees and was elected Chapter Commander (2000-2001). He currently is chairman of the chapter's Membership and Patriotic Education Committees and serves as Director of the Augusta YLC.

His last active duty assignment was the PMS of the Army ROTC at the University of Mississippi from 1990 until his retirement in 1993.

Since retirement, LTC Engen served as the ROTC SA at Lakeside High School, Evans, Georgia from 1993-2006. He also has coached the Augusta State University Rifle Team for the past 6 years. He is a member of numerous other associations including life membership in the American Legion, MOAA and the NRA.

LTC Engen's education includes a BS in Math from North Georgia College, and both a MS and CAS in Education/Computer Science from Northern Illinois University. VCINC CAPT JOHN HAYES is the Military and Veterans Affairs Liaison for Congressman Kenny Marchant, 24th Congressional District in Texas. Since January, 2006, he has been the liaison working with the military and veteran constituents of the 24th Congressional District.

From 1972 to 2005 Mr. Hayes served as an airline pilot. He flew for Braniff and US Airways. He retired as a Captain with over 24,000 flying hours. His FAA certificates include Airline Transport Pilot, Flight Instructor, Flight Engineer, and Ground Instructor. From 1967 to 1972 he served in the United States Air Force as a pilot, achieving the rank of Captain. His initial pilot training was at Webb AFB in Big Spring, Texas. Captain Hayes served as an Aircraft Commander on the C-141 at Charleston AFB, South Carolina, and as Chief Flight Examiner, Instructor Pilot, and Supervisor of Flying on the EC-47 at Phu Cat AB and Danang AB, Republic of Vietnam. During his military service Captain Hayes flew 166 combat missions and was awarded the Distinguished Flying Cross, Air Medal, Air Force Commendation Medal, Presidential Unit Citation ribbon, Air Force Outstanding Unit Award ribbon, Combat Readiness Medal, National Defense Service Medal, Armed Forces Expeditionary Medal, Vietnam Service Medal, Air Force Longevity Service Award ribbon, Small Arms Expert Marksmanship ribbon, Republic of Vietnam Gallantry Cross, and the Republic of Vietnam Campaign Medal.

Mr. Hayes graduated from Southern Methodist University (SMU) in 1967 with a Bachelor of Science degree. He was active in the Air Force ROTC program at SMU, serving as Corps Commander and as National Administrative Officer of Arnold Air Society (an AFROTC National Honor Society).

Mr. Hayes is active in many civic organizations in his community. He is a Master Mason, and the 2007 recipient of the Masonic Community Builder Award from the Dallas Tannehill Lodge. In MOWW, he is currently serving as Vice Commander-in-Chief and National Membership Committee Chairman. He was the 2009-2010 Region VIII Commander, the 2006-2007 MOWW Dallas Chapter Commander, and the 2006, 2008, and 2009 Director of the MOWW Youth Leadership Conferences in Fort Worth. He served as Chairman of the 2007 Dallas Veterans Day Parade, and is on the Board of Directors of the Greater Dallas Veterans Foundation and the Dallas Maritime Museum Foundation. He is a member of the Navy League, and serves on the Board of Directors of the Navy League's Dallas Council. Black, III, and LTC Ruth L Hamilton, both from the General George G. Meade, Maryland, Chapter. His three Committees are Legislative & Resolutions, Homeland Security, and Information, Publicity & Magazine, in addition to the Council of Region Commanders.

MOWW's 2010 Distinguished Service Award Recipient

The 2010 Distinguished Service Award (DSA) recipient is Lieutenant General Robert F. Foley, United States Army (Retired), awardee of the Medal of Honor. The Military Order of the World Wars’ 2010 National Convention, held in El Paso, Texas, was a great success. The Order elected Senior Vice Commander-in-Chief, Col Clifford D. “Cliff” Way, Jr., Dallas, Texas, Chapter, to be the Order’s 80th Commander-in-Chief (CINC). In addition, the Order elected VCINC CAPT Russell C. Vowinkel, San Diego, California, Chapter to be the Senior Vice CINC and also reelected one Vice CINC and elected three new Vice CINC’s. Information about these Officers is on pages 4-7 in this issue.

Outgoing CINC COL Philemon A. “Phil” St. Amant II, General Middleton/Baton Rouge, Louisiana, Chapter, nominated, and the General Staff (GS) approved, COL Billie L. Stephens, Phoenix, Arizona Chapter and Companion Mrs. Patricia J. Snyder, Greater Kansas City, Missouri Chapter for election to be General Staff Emeritus (see page 22).

The Order passed two Resolutions: “In Support of the Boy Scouts of America” in recognition of the 100th anniversary of the Boy Scouts of America (page 21); and a Resolution of Affiliation between “The Military Order of the World Wars” and “The Arnold Air Society” to promote and expand participation and involvement in mutually beneficial programs throughout the Nation for a better America (page 18). (The Chapters, Departments, and States, along with individual Companions can download a copy of these Resolutions from the MOWW web site.)

A complete list of the Order’s National Officers and the Chairs of the Order’s 21 Committees and two Councils are listed on page 12 and a list of these Chairs along with their Vice Chairs and their email addresses are on page 17 in this issue.

The recipients of the Order’s National Citations are listed on page 13. The list of the Chapters and individual Companions who were the National Award winners for FY 09-10 are listed on pages 14-15, and the winners of the MOWW Membership Citations on page 24.

The 2010 National Convention started on Tuesday, August 3rd with a fun-filled best ball-scrabble golf outing and a host Chapter workshop to discuss the operations of this National Convention. In the evening, the Youth Enrichment Foundation (YEF), Inc., held their semi-annual

board meeting to plan their support of the many MOWW youth activities.

On Wednesday, August 4th, the morning was a very busy time with the Budget Committee meeting. They worked to produce a balanced FY 10-11 budget. After in-depth discussions, the Budget Committee recommended for FY 10-11 a draft budget of \$792,796, income and expenses, which was presented to the National Convention and approved. This meeting was followed by the Executive Committee (EXCOM) of the General Staff meeting which discussed a myriad of issues about the Order.

The afternoon started with the MOWW Board of Trustees meeting and discussing the investment strategies for the Order’s funds, followed by the Policy, Planning Committee which continued their important work for the Order’s future, discussing the approved Revision C to the MOWW Strategic Plan 2010 and developing the MOWW Strategic Plan 2015. The Chapter Activities & Awards and National Security Committees held committee meetings grading the Chapter’s submittal for these respective National Awards. The Constitution & Bylaws (C&BLs) Committee held a meeting to discuss and prepare for their presentation of the proposed changes to the Order’s C&BLs to the National Convention. One of the last two activities for the afternoon were a Homeland Security Committee meeting with Mr. Michael Ada. Mr. Ada presented an informative seminar about his work as an Emergency Preparedness Manager assisting his native state of Texas and drew on his experience serving Active Duty in both Operation Iraqi Freedom and Operation Enduring Freedom in Afghanistan. The Information, Publicity, and Magazine Committee workshop gave Chapter officers a forum to discuss ways to improve publicity for the chapters in their local communities.

The day concluded for Companions with the MOWW Welcoming Reception which gave all Companions and their spouses and friends a great chance to socialize with all in attendance. Everyone had a fun time mixing with their fellow Companions and friends from every corner of our Country.

A busy schedule of morning meetings was held on Thursday, August 5th, starting with the Council of Past CINC’s holding a working breakfast meeting, and the Council of Region Commanders and the Council of Department and State Commanders holding a joint meeting to work on issues related to the responsibilities. The Patriotic Education Committee held a meeting for all Youth





Leadership Conference (YLC) Directors and their staffs to work on the many critical issues associated with operating the many multi- and single-day YLCs for the Order. The Legislation and Resolutions Committee held a productive meeting reviewing and finalizing the many resolutions presented to them from Companions and Chapters of the Order, and was followed by the Hann-Buswell Memorial Chapter holding their annual Chapter meeting.

The afternoon started with the very important Chapter Officers Information Briefing and new attendees' orientation to the National Convention. This briefing and orientation was followed by the Law & Order Committee meeting that discussed ways to improve the Chapter Law & Order programs. The last activities of the afternoon were the Regional Caucuses, held to give Companions running for an elected National Officer position a chance to introduce themselves and answer questions about what they would do for the Order if elected. It also provided time for the Region delegates to discuss each candidate. Following these Region Caucuses, the Order's Nominating Committee conducted the nominating process for the 16 National Officers positions. The day was concluded with the Hann-Buswell Memorial Chapter's formal reception and banquet.

Friday, August 6th, was another day of doing the work of the Order and having fun. It started with the opening ceremony and a joint meeting of the Pre-Convention GS meeting and first session of the National Convention. For the ninth year, the Order combined the Pre-Convention GS meeting with the National Convention sessions, which was again a success and well received by everyone. During this session the Order's National Officers were elected for the Fiscal Year 10-11 (see page 12). At the MOWW Awards Luncheon CINC COL St. Amant II presented the annual awards to the Chapters and individual Companions (see pages 14-15). The MOWW Awards Luncheon also served as a National Security Seminar by allowing for a prominent National Security speaker to address the National Convention. Mr. Terrell T. Kelley, Chief of Predictive Analysis and Targeting at the El Paso Intelligence Center (EPIC), a Multi-Agency National Intelligence Center, gave a very informative presentation about the issues and concerns related



to the work of EPIC and their efforts in providing intelligence support to the Nation's air, land and sea ports of entry and all twenty Border Patrol Sectors. His presentation was well received by all.

Following this luncheon two very successful seminars were completed: the Membership Seminar and the Chapter Activities & Awards Seminar. Both seminars were well-attended and highlighted numerous issues that impact on the day-to-day work of the Order. On Friday evening the Order's Treasurer General, LTC John Hollywood, conducted a workshop to present information on how Companions can leave money to the Order in their wills and trusts. This presentation was the second year of this type of workshop for the Order and the feedback from the Companions in attendance was that this meeting was well-received and much appreciated.

Saturday, August 15th, was not a day to relax for the delegates! The day opened with a moving memorial service for all Companions of the Order who passed onto their final resting place since the last National Convention. All Companions in attendance were grateful for the beautiful memorial ceremony. The day continued with the second session of the Joint Pre-Convention GS meeting and National Convention. At the end of this 2nd session, the Pre-Convention GS meeting was adjourned and the second session of the 2010 National Convention was recessed and was immediately followed by the Post-Convention GS meeting where CINC-elect Col Cliff Way announced his 21 committee chairs and announced the chairs of the two Councils who elect their Council Chairs. CINC-elect Col Way also nominated to the GS the five Assistants (Treasurer General, Chaplain General, Surgeon General, Historian General, and Judge Advocate General) and they were all approved (see list of Committee Chairs and assistants on page 17). He also nominated a member to serve a one-year term on the MOWW Ethics Committee and the MOWW Board of Trustees and a Chairman of the MOWW Board of Trustees and the Gist Blair Fund, and all were approved by the General Staff.

Following lunch the last two seminars were completed. The Patriotic Education and ROTC Seminars were held with

a great exchange of information on these two very important programs for the Order. Following these seminars, the Boy & Girl Scouts Committee held a meeting attended by all addressing the many issues related to the partnership between the Scouts and MOWW.

Following this busy day of work, the evening was completed with the CINC's formal reception and banquet. Outgoing CINC COL St. Amant II announced that the 2010 Distinguished Service Award (DSA) was awarded to LTG Robert F. Foley, U. S. Army, Retired, who was also a recipient of the Medal of Honor. General Foley, a great soldier, distinguished American, and a dedicated patriot was not able to attend the 2010 National Convention to receive his award due to an important schedule conflict. CINC COL St. Amant II informed the Order that the decision was made to proceed with the awarding of the Order's DSA award to General Foley despite the requirement that the recipient be present to be eligible to receive the award. In his absence, outgoing Chief of Staff BG Roger C. Bultman addressed the banquet and highlighted both the Companions and events that impacted him and the Order during his ten years as the Order's Chief of Staff. After his comments, CINC COL St. Amant II presented the Commander-in-Chief Award to Past CINC LTC Alfred Shehab, General George Meade, Maryland Chapter. This award is presented each year by the Commander-in-Chief to the Companion he feels has rendered the greatest service to him and the Order during his tenure as Commander-in-Chief. CINC COL St. Amant II commended Past CINC LTC Shehab for his counsel and support to him during his term. It was a wonderful night for all and the evening concluded with the change of the commander-in-chief from the now-Past CINC COL St. Amant to the new CINC Col Way.

On Sunday, August 8th, as many of the Companions headed home, CINC Col Way hosted his Post-convention EXCOM meeting, while his wife Jackie held a breakfast for the EXCOM member's spouses. CINC Col Way best summarized the 2010 National Convention by stating that everyone worked hard, had fun and had the opportunity to meet and discuss the great achievements of the Order over the past years. He also stated that the excitement of this great National Convention will be carried by all Companions back to their chapters. In addition, he reported that all indications are that all Companions were pleased with the informative presentations and the wonderful exchange of information during the seminars, committee meetings and on the convention floor. He stated that his goals for the upcoming year will be published in his CINC's Comments in the September issue of *Officer Review* magazine.

I close my report by thanking all Companions for their trust, support, and dedication during my ten years serving the Order as your Chief of Staff. In addition, the leaders of your Order hope to see you at the 2011 National Convention to be held in Bozeman, Montana, on July 18 to 24, 2011.

NATIONAL AWARD WINNERS



THE YOUNG MEMBERS RECRUITMENT

AWARD, formerly the L. Clifford Davidson Memorial Award. This award is given annually to the Chapters that achieve the most significant contribution to the future of the Order based upon the recruitment of members 50 years of age or younger.

The winner was the **Dallas, Texas, Chapter**. The first runner-up was the **Augusta, Georgia, Chapter**. An individual plaque accompanies this award and is presented to a member of the winning Chapter with exceptionally distinguished involvement and leadership. The winner was **LTC David T. Pitts** of the **Augusta, Georgia, Chapter**.

THE NATIONAL SECURITY AWARD, formerly the Clearwater Chapter Award, is given annually to recognize Chapters for their work in National Security and that have demonstrated the most effective local programs in support of the Resolutions pertaining to National Security passed by the Order in National Conventions and Midwinter General Staff meetings. This award has three categories, but this year we only have candidates for the large Chapter Category.

In the large category (100 or more members), the winner was the **Columbus, Georgia, Chapter**. The first runner-up was the **Dallas, Texas, Chapter**; the second runner-up was the **El Paso, Texas, Chapter**.

THE INFORMATION, PUBLICITY AND PUBLIC RELATIONS AWARD, formerly the Denver Cup, is given annually to the chapter with the most effective programs in the fields of internal communications, community and public relations, and utilization of television, radio, and other news media. The award is given in three categories, small, intermediate, and large.

In the large category the winner was the **Dallas, Texas, Chapter**. The first runner-up was the **El Paso, Texas, Chapter**. In the intermediate category the winner was the **Sun City Center, Florida, Chapter**, the first runner-up was the **Roanoke, Virginia, Chapter**. In the small category the winner was the **Fort Knox, Kentucky, Chapter**.

THE CHAPTER NEWSLETTER AWARD was established and approved at the 2007 National Convention. This new award is given in three categories, small, intermediate, and large.

In the large category the winner was the **Dallas, Texas, Chapter** and the first runner-up was the **San Diego,**

California, Chapter. There was a tie for the second runner-up—the **General Hoyt S. Vandenberg, California, Chapter** and the **El Paso, Texas, Chapter**. In the intermediate category the winner was the **Sun City Center, Florida, Chapter**; the first runner-up was the **Pinson Memorial, Texas, Chapter**; and an Honorable Mention was awarded to the **Topeka, Kansas, Chapter**. In the small category the winner was the **Fort Knox, Kentucky, Chapter**, and the first runner-up was the **Captain Dilworth, Texas, Chapter**.

THE INDIVIDUAL MEMBERSHIP RECRUITMENT AWARD, formerly the Chicago Award, is given to the Companion who personally recruits the greatest number of new Companions each fiscal year. The winner, with 18 new members, was Past CINC Col **James D. Elmer** of the Central Arkansas Chapter. There was a tie for first runner up—**CDR Robert L. Gillen** of the Cape Cod, Massachusetts, Chapter and **LTC Joseph M. Tarantino** of the Richmond, Virginia, Chapter with 13 new members each. The second runner-up was **CPT Allen B. Clark, Jr.** of the Dallas, Texas, Chapter with 12 new members.

THE CHAPTER PATRIOTIC EDUCATION PROGRAM AWARD, formerly the Commander J. Paul Scheetz/Pittsburgh Chapter Patriotic Award. This award is bestowed on the Chapter receiving the highest number of points for activities in the implementation of the MOWW Patriotic Education Program during the preceding twelve months. The award is given in three categories, small, intermediate, and large. In the large category the winner was the **El Paso, Texas, Chapter**. The first runner-up was the **Augusta, Georgia, Chapter**, and the second runner-up was the **Dallas, Texas, Chapter**. In the intermediate category there were no eligible Chapters. In the small category the winner was the **Harvey Latham, Oregon, Chapter**. The first runner-up was the **Fort Knox, Kentucky, Chapter**.

THE CHAPTER LAW AND ORDER PROGRAM AWARD, formerly the Tacoma Law and Order Program Award, was instituted in 1995 to encourage law and order activities at the Chapter level and to honor those Chapters for their participation in support of this tenet of our Preamble, "Ever to maintain Law and Order." The award is given in three categories, small, intermediate, and large, but this year we only have candidates for the large and small Chapter Categories. In the large category the winner was the **El Paso, Texas, Chapter**. The first runner-up was **Dallas, Texas, Chapter**; the second runner-up was the **Augusta, Georgia, Chapter**. In the small category the winner was the **Pinson Memorial, Texas, Chapter**.

THE NATIONAL LAW AND ORDER

INDIVIDUAL AWARD was created to recognize the most outstanding law enforcement or criminal justice official in the United States of America (including Puerto Rico, Guam, Virgin Islands, and the District of Columbia). This award was approved at the 2001 National Convention. The winner, and sponsoring Chapter, is announced at each National Convention with the actual presentation of the award to be made at an appropriate local ceremony to achieve maximum community visibility.

This year's winner was **Police Officer Ricardo Yanez** of the El Paso, Texas, Police Department, and the submitting organization was the **El Paso, Texas, Chapter**.

THE NATIONAL LAW AND ORDER OUTSTANDING PERFORMANCE AWARD was created to recognize exceptional performance for heroic actions. The winner, and sponsoring Chapter, is announced at each National Convention with the actual presentation of the award to be made at an appropriate local ceremony to achieve maximum community visibility.

This year's winner was **Agent Colin Parks** of the Arizona Border Patrol, and the submitting organization was the **Santa Cruz, Arizona, Chapter**.

THE CHAPTER ACTIVITY AWARD, formerly the Memphis Cup. This award recognizes the great work the Chapters accomplished during the past year. The award is given in three categories, small, intermediate, and large. In the large category the winner was the **Dallas, Texas, Chapter**. The first runner-up was the **El Paso, Texas, Chapter** and the second runner-up was the **Augusta, Georgia, Chapter**. In the intermediate category the winner was the **Sun City Center, Florida, Chapter**. The first runner-up was the **Phoenix, Arizona, Chapter**. In the small category the winner was the **Fort Knox, Kentucky, Chapter**.

THE CHAPTER COMMANDERS AND ADJUTANTS ATTENDANCE AWARD is presented to the region with the highest percentage of Chapter Commanders and Adjutants attending the seminars at the National Convention. The host Region is not eligible to compete for this Award. The winner was **Region VIII** (Oklahoma and Texas, except El Paso, TX, which is Region XIII).

THE ROTC AWARD, formerly the Brown Cup, is conferred on Chapters that provided the best support of Junior and Senior ROTC units. There are six categories of support being recognized.

In the category of support for 1–18 ROTC units, the



winner was the **Apache Trail, Arizona, Chapter**. The first runner-up was the **Mesilla Valley, New Mexico, Chapter**; the second runner-up was the **Topeka, Kansas, Chapter**.

In the category of support for 19–24 ROTC units, the winner was the **San Diego, California, Chapter**. The first runner-up was the **Columbus, Georgia, Chapter** and the second runner-up was the **Phoenix, Arizona, Chapter**.

In the category of support for 25–32 ROTC units, the winner was the **Augusta, Georgia, Chapter**. The first runner-up was the **El Paso, Texas, Chapter**; the second runner-up was the **Fort Worth, Texas, Chapter** and an Honorable Mention was awarded to the **Savannah, Georgia, Chapter**.

In the category of support for 33–45 ROTC units, the winner was the **Richmond, Virginia, Chapter**. The first runner-up was the **Denver, Colorado, Chapter**; the second runner-up was the **Fort Knox, Kentucky, Chapter**.

In the category of support for 46–64 ROTC units, the winner was the **Puget Sound, Washington, Chapter**. The first runner-up was the **Dallas, Texas, Chapter**; the second runner-up was the **San Antonio, Texas, Chapter**, and an Honorable Mention was awarded to the **Memphis, Tennessee, Chapter**.

In the category of support for 65 or more ROTC units, the winner was the **Philadelphia, Pennsylvania, Chapter**. The first runner-up was the **Columbia, South Carolina, Chapter**; the second runner-up was the **Atlanta, Georgia, Chapter**, and an Honorable Mention was awarded to the **General Middleton-Baton Rouge, Louisiana, Chapter**.

THE NATIONAL UNIT MEMBERSHIP AWARD was established and approved at the 2003 National Convention to promote recruiting and retention of membership within the Order by recognizing the Chapter, Department, and Region with the greatest percentage increase in net new members based on an annual percentage increase of living members. There is an exclusion of participation by new Chapters for two years from the date of their chartering. In the Chapter competition the winner was the **Central Arkansas Chapter**, with an increase of 34%. In the Department competition the winner was the **Department of Massachusetts** with an increase of 13%. In the Region competition the winner was **Region VII** (Alabama, Arkansas, Louisiana and Mississippi) with an increase of 8%.

THE GENERAL STAFF OFFICERS ATTENDANCE AWARD, (The BG Horace W. Port Award, formerly presented at the Midwinter General Staff Meeting) is presented to the Region with the highest percentage of National General Staff Officers in attendance. The winner was **Region XIV** (California, Hawaii and Nevada).

Why is our national rate of participation in our Constitutional right of voting so low and how can we improve it?

Apathy and Ignorance: Threats to Voter Participation

Over the last forty years, the trend to exercise our Constitutional right to vote has been steadily declining in the United States. Sixty percent of eligible voters cast ballots in the 1968 general elections, less than 52% in 2000, and only 40% voted in the 2002 elections. This decline in voter turnout is likely a combination of many causes. "Voter apathy" is a common explanation for low voter participation. But why are most of us apathetic toward determining our future? The perception of being too busy to vote, confusion created by media overload, the defeatist "my vote doesn't make a difference" attitude, decreasing confidence in the integrity of the election system, and diminishing trust in politicians all play a role. However, excessive preoccupation with self-interest and insufficient understanding of political issues are the primary causes for the current decline in voter participation.

Sadly, the majority of American citizens are most motivated by their own welfare and comfort. It seems no longer feasible to influence the population by ennobling them with patriotic thoughts and reminders of their civic duty. In today's America, the most effective way to increase voter participation is to offer a meaningful incentive—for example, a tax deduction. Each time someone votes, he would be entitled to claim a deduction to his adjusted gross income for that year's tax return. Providing a reward appeals to the most innate tendencies of people, and therefore will be extremely effective.

Moreover, people generally lack a basic understanding of each candidate's position on political issues or the ramifications of the issues themselves, and thus cannot cast a meaningful and confident vote. Today, potential voters are bombarded by negative "attack ad" mass media campaigning, rather than educated by useful public debates. In the midst of their busy schedules, most citizens find it too difficult to research candidates and ballot measures to decide which they support. My own family is very patriotic. My grandparents served in both the Air Force and the Navy. Despite a sincere desire to exercise their privilege to vote, my parents often cannot find the time—between work, driving me to piano lessons, coaching my track team, making dinner—to research each candidate and issue. They know who they support for President; but they are unhappily uninformed on most of the state and local issues, and regret leaving those ballot boxes blank. Informed voter participation can be improved by promoting accurate, non-partisan media coverage. This can be accomplished by creating an organization that reports factual information to the public on the major issues, measures, and candidates. Campaign finance reform would provide the funding for this organization, requiring each candidate or measure support-group to contribute a certain percentage of their campaign budget. If people are informed, they will be eager to vote.

Abraham Lincoln once said that "the ballot is stronger than the bullet." Only by combating apathy and ignorance, through offering incentives and informing voters, can we all vote for the candidates, laws, and policies that will shape our future.
