
CINC LTC Hamilton became an Adjutant General's Corps officer upon her commissioning in 1985. During 26 years of service in worldwide assignments, her unique experiences include serving as the first female Honor Guard Commander (LANDSOUTHEAST, Izmir, Turkey) while assigned as the NATO Morale Welfare Activities Officer. She also commanded the 178th Personnel Service Company (Aschaffenburg, Germany) as a first lieutenant, service as the Assistant Executive Officer to the Supreme Allied Commander of Europe and the Commander-in-Chief, US European Command, and as the Executive Officer for two The Adjutants General of the US Army. Prior to her election as a CINC, she served as: an elected General Staff Officer; an appointed member of the EXCOM; Chair, Legislative & Resolutions Committee; Chair, Honors & Protocol Committee; Vice Chair, Magazine Committee; and, Constitution & Bylaws Committee member, a VCINC and the SVCINC. CINC Hamilton has bachelor's degrees in Nutrition Education, Dietetics, and Home Economics Education from Indiana University of Pennsylvania. She also holds a Master of Human Relations degree from the University of Oklahoma.

SVCINC COL Le Grande received a BA degree (History) from Louisiana Tech University in 1968. He received a direct commission in the Adjutant Generals Corps in 1978 after 10 years of enlisted service. He served in combat service support units from Company to Theater Level. His culminating assignment was Commander, 321st Theater Materiel Management Center, for Third Army forces in the Middle East & Southwest Asia (with service during Operation ENDURING FREEDOM and Operation IRAQI FREEDOM). He retired from the US Army in 2003 with 35 years of active and Reserve service. As a member of the Gen Middleton Chapter, COL Le Grande served as Vice Commander for Youth Leadership, Vice Commander for Membership, and as Chapter Commander. He also served two years as Louisiana Department Commander and is serving his fifth year as Region VII Adjutant. COL Le Grande served as Chair of the committee tasked to develop the Order's new Chapter Activity Report and has completed three years as VCINC.

VCINC MG Jacka is the Executive Director for the Kansas Homestead Rehabilitation Corporation, a private, non-profit financial corporation providing low-interest agricultural loans to Kansas farmers experiencing financial distress. Previously, he was the Secretary of Agriculture and Assistant Secretary of Agriculture for the State of Kansas for 26 years. Retired from the US Army in 2008 after 37 years, he is a graduate of the Command and General Staff College and the Army War College. He served in command positions at every level. He deployed for Operations Iraqi Freedom and was the Commanding General, V Corps (Rear) Provisional. His last assignment was the Deputy Director, Global Sustainment (JCS/J-4). He is a recipient of the Distinguished Service Medal, Legion of Merit (2-OLC), Meritorious Service Medal (2-OLC). Army Commendation Medal (3-OLC), and the Army Achievement Medal. MG Jacka is a Companion of the Topeka, BG Hoisington, and Hann-Buswell Chapters. He is the past Commander of the Topeka Chapter; past General Staff Officer (Elected); and is the Kansas Department Commander. He holds a Bachelor of Arts and Master of Arts degrees in Political Science (Kansas State University).

VCINC COL Beasley was a Distinguished Military Graduate from Central State University (Wilberforce, OH). Commissioned in 1973 (Infantry), he later transferred to the Adjutant General Corps. He served in a variety of command and staff positions throughout CONUS and OCONUS, retiring in 1998 after a 28-year career. Later, he was a defense contractor for Fortune 500 (Lockheed Martin, Serco, Inc.) and other companies, e.g., his current employer (AMTIS, Inc.). During his corporate years, he accumulated over 15 years' experience as a CEO, VP, Business Consultant, Program Manager and Project Director. He holds a Master's Degree from Central Michigan University, and is a graduate of the Army Command & General Staff College and the Army War College. In June 2013, he began a two-year elected term as President, National Memorial Day Association (Sate of Georgia). He has been a member of the Atlanta Chapter for 15 years and has held the following MOWW leadership positions: Junior Vice Commander, Senior Vice Commander and Commander (Atlanta Chapter), and Treasurer General Staff Officer, and Commander (Region V).

VCINC LTC Hollywood graduated from California State Polytechnic University (San Luis Obispo, CA) in 1968, after which he was commissioned in the Regular Army. His assignments include Reconnaissance Platoon Leader, 82nd Airborne Division; Interrogation Officer, 1st Infantry Division, RVN; Instructor, at two service schools; Organizational Development Staff Officer, Field Station Berlin, GE; Operations Officer, 766th MI Detachment, Berlin, GE, (where he planned and participated in an operation that resulted in the arrest of an East German agent who was trying to recruit American service members for espionage); U.S. Army Recruiting Command, Ft. Sheridan, IL; S-3, First Recruiting Brigade, Ft. Meade, MD; Acting Commander, Boston Recruiting Battalion, Boston, MA; Deputy Commander/Operations Officer, Personnel Security Clearance Facility, Ft. Meade, MD. He retired from active duty on 30 June 1990. As a member of the MOWW, he has served as Treasurer General; General Staff Officer, (elected); Senior Vice Commander Region IV; Department of Maryland Commander, Commander of the MG Meade Chapter, and as the Order's VCINC.


SATURDAY, 8 AUGUST 2015 Memorial Service, Business Session, CINC Banquet

ince its founding, the United States of America has been known to be the land of freedom and opportunity. Throughout our history, millions of immigrants have come to this country to practice these freedoms, and many have died, including their descendants, to protect them. America is known as "The Melting Pot of the World" because different kinds of people with diverse ethnic origins immigrated here to pursue the American dream. I believe all opportunities should be equally available to all citizens who live in this great nation regardless of where they were born. These opportunities should include the ability for any citizen who is qualified to run for President.

As stated in Article 2 Section 1 of the United States Constitution, "No person except a natural born citizen shall be eligible to the Office of the President; neither shall any person be eligible to that office who shall not have attained to the age of thirty five years, and been fourteen years a resident within the United States." I believe the first half of this requirement should be revised to include all citizens.

As stated in Article V of the Constitution, "The Congress, whenever two thirds of

both Houses shall deem it necessary, shall propose Amendments to this Constitution...." If two thirds of the states believe that all citizens who have been living in this nation for over fourteen years, and are over thirty-five years of age deserve a chance to become the President of the United States, then Article 2 of the Constitution can and should be amended. Dentistry Past and Present

hen I was young, people put their teeth in a glass by the bedside each night. Back then we felt grateful for the advances in false teeth over George Washington's wooden choppers. (Actually, Washington had wooden frames with elk's teeth implanted. They were

activated by metal springs. Check out a dollar bill and you can see the fullness and imagine the discomfort.)

The first tooth brushes were mashed sticks used to scrape the teeth and gums. The Chinese used the first bristle brushes and in the 17th century they came to Europe. Colonial American dentists advised their use in the new world. The year 1880 saw the first electric tooth brush. A rather cumbersome thing. It wasn't until the 1960s that they became practical and finally cordless. A decent electric brush can now be purchased for about \$5 at a discount store.

The ancients developed "tooth paste"—ground shells flowers, fruit, as well as mice heads, lizard livers and urine were used! Many ingredients were abrasive and destroyed enamel. The 1800s saw soap and chalk's introduction the start of modern products. Just as the can opener was

invented long after the tin can it was 1892 before the collapsible tooth paste tube was invented.

There have been numerous technical advances in dental care. In the beginning, pulling a bad tooth was the only therapy. Use of a tooth key...a strong metal devise that fit under the roots and operated with a twist was common. They either "popped" out the tooth, broke the jaw or removed the tooth's top (crown). Perhaps the best thing that came out of the civil war in New Mexico (yes there was a significant campaign, Texans fighting Coloradans generally) was Dr. Edmund Covey's later role as hospital inspector in the "north south." He found a surgeon placing a rubber channel under broken jaws and wiring this splint in place. Thus broken jaws healed regularly.

Drilling out decay and placing gold, silver amalgamated with mercury, etc. Today's porcelain teeth were first invented in 1774. In 1882 the practice of implanting "new" teeth in blank spots started. A root canal was a needed painful experience until high speed drills were invented. When false teeth are the only answer today they are made of plastic or ceramic.

Anaesthesia such as nitrous oxide (laughing gas), when purified and used with oxygen, remains a stable, safe determent to pain with a quick recovery. The first local anesthetic was cocaine. Its addicting properties lead to procaine (Novocain) and numerous other local anesthetics. Now we can have painless procedures. That is, until the local wears off.

Today dentistry is safe, usually painless, and remarkably successful in reconstructing a normal comfortable mouth. Most of our fears turn out to be without substance once we get to the office. *


This kind of goodness comes from people with a strong inner character who have a pure and steadfast hearts. They will choose to:

VA Announces New Rules Regarding Service Animals in VA Facilities

The VA announced that it has revised its regulation regarding the presence of animals on VA property. The updated regulation will ensure



VA practices remain consistent with applicable federal law. It will also assist individuals entering VA facilities in developing a clear and consistent understanding of the criteria governing facility access for service animals.

Under the revised regulation, only dogs that are individually trained to perform work or tasks on behalf of an individual with a disability will be considered service animals. Other kinds of animals will not be permitted in VA facilities, unless expressly allowed as an exception under the regulation for activities such as animal-assisted therapy or for other reasons such as law enforcement purposes.

In accordance with required practices, the revised regulation was published in the Federal Register in November 2014, to obtain feedback from Veterans, advocacy organizations and other stakeholders.

Over the next thirty days, VA will provide training to frontline employees and ensure policies at all facilities are consistent with the new regulation.

The Office of Advocacy and Outreach (OAO),

created by the 2008 Farm Bill, coordinates programs and outreach across USDA for several underserved groups of farmers and ranchers. While no federal programs exist specifically for veteran farmers and ranchers, financial and resource management

National Day of the Deployed was founded in 2006 by Shelle Michaels Aberle. Ms. Aberle approached then North Dakota Governor John Hoeven for support of a ND Proclamation for the day. Governor Hoeven was the first Governor in the United States to note the deployed troops in a formal proclamation.

Grand Forks, ND, hosted the first event. The first units honored by this proclamation were: NDARNG 1-188th ADA SECFOR and JLENS deployed to Afghanistan. In 2011, Senator John Hoeven co-sponsored S.RES.295 for a national day of honor. On 18 Oct 2011, it was passed unanimously as the first national day honoring the deployed troops and their families.

In 2012, all states across the nation observed the United States' Resolution for National Day of the Deployed.

October 26, 2014 marks the anniversary of the ninth annual Day of the Deployed and the fourth annual National Day of the Deployed. ★
