

CINC CAPT RUSSELL C. VOWINKEL, USN (RET); SAN DIEGO CHAPTER (CA)



CINC Vowinkel was commissioned as an Ensign in the US Navy in 1962 after completing Aviation Officer Candidate School in Pensacola (FL). Captain Vowinkel served on active duty from 1962-1967 and served in the Viet Nam War Theater of Operations as a Naval Flight Officer. Captain Vowinkel completed 28 years on Active and Naval Reserve duty during which he successfully served three command tours. In MOWW, Captain Vowinkel served as a chapter commander, a department commander, the Region XIV Treasurer, the Region XIV Vice Commander, an elected General Staff Officer, and National Information and Publicity Chair. At the 2008 National Convention, he was elected Vice Commander-in-Chief (VCINC) and last year was elected the Senior VCINC of the Order. Captain Vowinkel is married to Perpetual Member, Companion Beverly Vowinkel, and they are the parents of two sons, both former Army officers and US Military Academy graduates. CINC Vowinkel resides part-time in Northern Virginia and part-time in Southern California. Son Brian is a Perpetual Member of the Puget Sound Chapter and son Kyle is a Perpetual Member of the Leigh Wade Chapter.

SVCINC COL M. HALL WORTHINGTON, USA (RET); GEN MEADE CHAPTER (MD)



SVCINC Worthington graduated from Baltimore Polytechnic Institute and the Johns Hopkins University. He also holds a master degree from Central Michigan University, and is a graduate of the US Army Command & General Staff College, and the National Defense University. He joined the National Guard in 1953 and was commissioned in 1957 through Officer Candidate School. During his 35-year Army career, he served in the National Guard, the Reserves and on Active Duty, primarily in the Military Police. He has been a MOWW member for over 17 years, and has served as MOWW's VCINC, its Treasurer General, its Assistant Treasurer General, a General Staff Officer, a Region, Department and Chapter Commander, and a Chapter Vice Commander, Treasurer and Adjutant. He and his wife Mary have three children and two grandchildren

VCINC LTC GARY O. ENGEN, USA (RET); AUGUSTA CHAPTER (GA)



VCINC Engen has a Bachelor of Science degree (Math) from North Georgia College and advanced degrees (Education/Computer Science) from Northern Illinois University. He was commissioned from Army ROTC in the Field Artillery in 1965 and enjoyed artillery and joint assignments during his 28 year career. His last assignment was as a Professor of Military Science at the University of Mississippi. After retiring, he headed the Lakeside High School JROTC (Evans, GA). 2011 MOWW NATIONAL CONVENTION:

Raising the Bar

The 2011 National Convention was held in Bozeman, Montana, and it was a great success by every measure—whether that measure was conducting business of the Order, providing educational forums, networking with Companions or just enjoying the very relaxed social atmosphere. With the support of the EXCOM, Past CINCs Bert Rice and Sam Wetzel, and the Gen Meade Chapter team, did an absolutely brilliant job in organizing a simply extraordinary national convention.



The approach to this year's convention schedule was different than was the case in past years, i.e., this enhanced approach

and schedule has established the approach for future conventions. For one, the "work" hours of the convention were generally from 0800-1700. That gave attendees informal off-time to spend with family and guests attending the convention and seeing the local sights. Additionally, social activities (tours, dinners, etc.) were scheduled in a way that didn't cause them to overlap (conflict with) business sessions. The enhanced schedule also permitted conference attendees to hold spontaneous meetings on various issues concerning the business of the Order.

Importantly, for the first time in MOWW's history, the 2011 National Convention Book contained the annual reports of every Na-

tional Officer, Region Commander, Committee and Council Chair, and more. This greatly facilitated programs and issues

being understood and addressed in various meetings and seminars, but also in general session. Equally significant, for the first time the 2011 National Convention Book is available on MOWW's national website for every Companion in the Order.

The Order elected Senior Vice Commander-in-Chief CAPT Russell C. Vowinkel (San Diego Chapter, CA) as the Order's 81st Commander-in-Chief (CINC). The Order also elected VCINC COL M. Hall Worthington (Gen Meade Chapter, MD), as

this issue. A full and updated national directory is on the streamlined national MOWW


Pre-convention activities began on Monday, 18 July 2011 with an enthusiastically-supported golf outing at the Cottonwood Golf Club and guided fly-fishing trips in Montana's beautiful streams. Throughout the day, final preparations for the National Convention kept many from the Gen Meade Chapter quite busy.

Tuesday, 19 July 2001, was a pre-convention day of increased activity. In addition to more fly fishing, attendees really got down to business. The day began with an EXCOM meet-

ing, followed by meetings of the Budget, Chapter Activity & Awards and the National Security Committees, the Board of Trustees, the Youth Enrichment Foundation (YEF) Board

meeting, and a very productive Council of Region Commanders meeting.

Wednesday, 20 July 2011, was a day of tours and fun. In addition to more fly fishing, the majority of Companions filled two large to tour buses and traveled to Yellowstone National Park where they saw "Old Faithful" and the stunning "Old Faithful Inn," but also gorgeous scenery at places such as Lake Yellowstone, the Hayden Valley, the upper and







lower falls of Yellowthe River, stone the Norris Geyser Basin Mamand Hot moth Springs. Impressive wildaboundlife ed-including deer, elk,

moose, buffalo and more. Other Companions participated in a tour of Bozeman, Montana, which included visiting the town itself, the Museum of the Rockies, the Pioneer Museum and the campus of Montana State University. The end of the day concluded with an exceptional CINC Welcome Reception, which was a casual dress chuck wagon buffet—and which was thoroughly enjoyed by all.



On Thursday, 21 July 2011, the focus of the day was the business of the Order. The Council of Past CINCs Breakfast began the day, immediately

followed by the Law & Order and Homeland Security seminar. Next was the important Chapter Officers & New Attendees Orientation session. This vital session will be enhanced this coming year and will ultimately be put on the MOWW website for use by Companions throughout the year. Next came the Patriotic Education Committee (PEC) meeting. Of particular note is Committee Chair COL Dick Minor linked the committee's objectives to those in the MOWW Strategic Plan—something CINC Vowinkel asks that every committee, council and board chair do. This session was followed by the Financial Development and Chapter Activities & Awards seminars, and by a very productive Scouting workshop.

After a Hann-Buswell Chapter meeting, the afternoon's activi-



ties were focused on the national officer nominating process organized and led by PCINC LTG Sam Wetzel, and followed by excellent candidate presentations by those running for national officer positions.

That evening Companions thoroughly enjoyed a din-



ner buffet and the performance of "The Ringling 5," a group of ranchers who write their own songs perform them with western panache! A highlight during that performance was PCINC LTC David Titus getting up on stage and performing with the group!

Friday, 22 July 2011, marked the formal opening of the 2011

National Convention. Conference attendees were welcomed by the Mayor of Bozeman, Montana. After approving the 2010 Convention minutes,



CINC Way presented the National Membership Awards and Citations. These presentations were followed by end-of-year reports by CINC Col Way, CS Brig Gen Morrill, SVCINC CAPT Vowinkel, and VCINCs COL Worthington, LTC Engen, Capt Hayes and HPM McIntosh. These were followed by reports from Board of Trustees and the Treasurer General.

President of the Board of Trustees CDR Art Judson reported on a very good year investment-wise, and Treasurer General LTC John Hollywood reported the Order operated in the black for the past year.

Next were the Budget, Policy-Planning, Membership, Patriotic Education, ROTC, Scouting, National Security, and Homeland Security Committee reports.

LTC Ruth Hamilton (Chair, Legislative & Resolutions Committee) then presented four proposed resolutions (i.e., "Ensuring National Security," "100th Anniversary of the Girl Scouts of the United States of America," "USS John F. Kennedy (CV-67) Relocation to Portland, Maine," and "Cold War Service Medal." All resolutions were approved, and are presented elsewhere in this issue. Next, the Youth Enrichment Foundation (YEF), Patriotic Education Foundation (PEF) and Nominating Committee reports were presented.



After approving the 2011-2012 MOWW Budget and all committee reports (see the 2011 National Convention Book), the National Convention and General Staff

Meeting was followed by the MOWW Awards Luncheon and National Security Seminar. The many awards recognized excellence in MOWW programs, newsletters, and key activity areas such as recruiting. The national security speaker, LTC Jeffrey F. Addicott, USA (Ret), presented his views on various terrorism issues. He is the Director of the Center for Terrorism Law at St. Mary's University School of Law, San Antonio,



Texas. That afternoon the conference attendees departed for Virginia City Visit, the West's best-preserved 1860s gold mining town, where they

viewed the town's historic buildings and furnishings, and attended a melodrama and a vaudeville show in the town's Opera House.

Saturday, 23 July 20 11, began with a heartfelt Memorial Service honoring departed Companions. Immediately following, the convention reconvened and the General Staff meeting was held. CINC-elect Vowinkel guided the session by announcing his Assistant National Officers, GSO, and committee appointments—including three *ad hoc* committees. These assignments are listed elsewhere in this issue.

That afternoon, while some convention attendees enjoyed a tour of Bozeman, Montana, others attended a number of very productive sessions. First was the ROTC/JROTC seminar, which provided a great deal of useful information for the coming year. Next was the Information & Publicity seminar, which was oriented to helping chapters market themselves during the coming year. The third was the very interactive Membership Seminar, during which Companions were highly engaged and shared many helpful suggestions with each other. The Policy-Planning and the Marketing Committees also met, providing much-needed information in these two vital areas.

That evening featured the CINC's Reception and MOWW's

Formal Banquet. During the reception, Gen and Mrs. Dunford met numerous attendees, who were struck by their easy-going manner.

During the banquet, the Phoenician Essay Award winner, Ms. Ciara



N. Ryan Todd, from the Texas Wesleyan University Youth Leadership Conference (TWU-YLC) was presented her award and a check for \$2,000. Her essay is elsewhere in this issue.

Gen Joseph F. Dunford, Jr., Assistant Commandant of the United States Marine Corps, was this year's Distinguished

Service Award winner. [See the July 2011 issue of the *Officer Review*" for his biography.] He provided a wideranging and candid presentation to banquet attendees, ad-



dressing Department of Defense, United States Marine Corps, and national security and budget issues. In doing so, he outlined their impacts on the Department of Defense in general and the United States Marine Corps in particular. He also provided very insightful thoughts on the way ahead. Finally, his praise of today's Marines and servicemen and servicewomen everywhere was both motivating and heartwarming. Equally heartwarming was his obvious respect of the role Veteran Service Organizations (VSO) play, highlighting MOWW in particular. The audience was clearly captivated.

The last portion of the Formal Banquet was the investiture of the 81st Commander-in-Chief of the Military Order of the World Wars, CAPT Russell C. Vowinkel, USN (Ret),

and the newlyelected National Officers of the Order. PCINC LTC Alfred H. M. Shehab, USA (Ret) and PCINC CAPT R. M. "Rollie" Stevens, USN (Ret), presided.









This dignified transfer of Order leadership was in keeping with the highest MOWW traditions.

The ceremony celebrated the leadership of PCINC Col Cliff Way while heralding the new leadership team led by CINC CAPT Russ Vowinkel. It was uplifting conclusion to the 2011 MOWW National Convention and ushered in the new MOWW operating year on an extremely high note.

On Sunday, 24 July 2011, as most of the Companions prepared to head home, CINC CAPT Vowinkel and his senior leadership team got immediately to business during the Post-Convention EXCOM meeting. During that meeting, he

emphasized the team approach, highlighting key leadership challenges and motivating all to build on past successes and accomplishments by raising the bar throughout our great Order. PHOENICIAN AWARD-WINNING ESSAY

In the United States of America (USA); a land with so many rights and freedoms; no citizen should be required to take part in any activities outside their civic duty to

The use of a constitutional federal republic style government is part of what makes the USA so strong and unique. This form of government was developed by those who believed that unalienable rights come from God, that everyone is free to pursue their own happiness, and that the citizens control the government; not vice versa. This is something that citizens in many other countries are denied and the reason why people emigrate to the USA every day.

The founding fathers knew too well the ways in which the state could tyrannize its people, and forcing its citizens to serve the government would be infringing on a basic liberty. Americans have the right to pursue happiness and if they do not want to participate in the military or in community service, they should not be required. Making such a commitment is a decision best left to the individual and it should be a decision made from the heart-- not from fear of punishment.

Forcing citizens to serve others can cause feelings of resentment in those opposed to serving. If serving others is not a person's own decision, it will show in their work. For example, in a recent human resources market research survey it was shown that people who were forced into community service did the absolute minimum required; however, those who had volunteered reported significantly higher levels of effort put in their service (United Way Campaign). I often hear the phrase, "There is nothing stronger than a volunteer." To me, this means that volunteers serve because they are passionate and dedicated to helping others. WHEREAS, the Girl Scouts of the USA, founded in 1912, stands as a leader of our Nation's heritage, wherein it has provided a youth movement based on principles of character, citizenship and fitness. The year, 2012, is an historic year for the Girl Scouts of the USA with its 100 years of achievement with our Nation's youth;

NOW, THEREFORE, be it resolved that The Military Order of the World Wars in convention in Bozeman, Montana, 18-24 July 2011, recognizes the great and significant contributions the Girl Scouts of the USA have made to our Nation's youth. We also congratulate them on this centennial anniversary, and we look forward to continuing a mutually beneficial relationship.

USS JFK (CV-67) RELOCATION TO PORTLAND, MAINE

WHEREAS, the Joshua L. Chamberlain Maine Chapter of The Military Order of the World Wars in a regular meeting, on 19 March 2011, voted to register its support for the relocation of the USS JFK (CV-67) aircraft carrier to Portland, Maine. (Casco Bay in Maine, on which Portland is located, was the home of the North Atlantic Fleet during World War II.) Acquiring this permanent berth would provide a floating museum for Northern New England honoring Military, Naval and Air Science, and those who served aboard the carrier; and

WHEREAS, this support would not incur any financial demands, directly or indirectly, on the part of The Military Order of the World Wars or the State of Maine; and

WHEREAS, support of this action would foster the patriotic education of our Nation and would recognize past Military, Naval and Air Science, which would be in harmony with the Preamble of the Constitution of The Military Order of the World Wars, and would provide a Naval/Military Museum for the Northeast United States and the Atlantic Provinces of Canada. This concept will likely be supported by the Congressional Delegation and it would serve to bolster a political as well as an historical and economic benefit to the area;

NOW, THEREFORE, be it resolved that The Military Order of the World Wars, in convention, in Bozeman, Montana, 18-24 July 2011, supports this resolution to seek a permanent relocation of the USS JFK (CV-67) aircraft carrier to Portland, Maine, for use as a floating museum.

COLD WAR SERVICE MEDAL

WHEREAS, the Armed Forces of the United States of America were in involved in a worldwide conflict recognized as "The Cold War" from 2 September 1945 until 26 December 1991, a period of time when United States service members and their families endured hardship, sacrifice, and perseverance, with some giving all. The individual and collective actions of the men and women of our Armed Forces resulted in the defeat of threats such as international communism and nuclear holocaust by the former Soviet Union and its allies; and

WHEREAS, these service members have never been recognized by a grateful Nation with a service medal decoration for their military sacrifices, yet the United States Senate has desired such recognition of these service members, with a medal decoration, beginning with the 105th Congress, and introduced bills eight times; and

WHEREAS, the United States House of Representatives has likewise called for the recognition of these service members with a service medal decoration, since the 106th Congress, and introduced bills five times with a vote "for" in the House version of the Defense Act of Fiscal Year 2008; and

WHEREAS, The Honorable Ms. Olympia Snowe, Senator from Maine, has introduced a Bill in the United States Senate, S. 402, "Cold War Service Medal Act of 2011," which now rests in the Senate Committee on Armed Services;

NOW, THEREFORE, be it resolved that The Military Order of the World Wars, in convention in Bozeman, Montana, 18-24 July 2011, endorses these separate, complementary, and continual actions of the United States Senate and House of Representatives reflecting a strong will by the Members of Congress and fully supports S. 402 for favorable consideration, and that the Secretary of Defense direct the Services to design, authorize, and supervise the issuance of the "Cold War Service Medal" to the aforementioned members of our Armed Forces recognizing their honorable service and sacrifice.

A RESOLUTION →

ENSURING HOMELAND SECURITY

WHEREAS, our Nation remains vulnerable to major terrorist attacks by individuals and groups that have made public threats against the United States and are known to possess the means and have the resolve to carry out attacks; and

WHEREAS, secure borders, coastal areas, and ports are vital to protecting our citizenry, our commercial and economic livelihood, and indeed our way of life; and

WHEREAS, the current national economic situation will likely require acrossthe-board funding cuts that potentially can be detrimental to Homeland Security programs essential to defending our Nation from terrorism;

NOW, THEREFORE, be it resolved that The Military Order of the World Wars in convention in Bozeman, Montana, 18-24 July 2011, strongly supports programs that maximize protection and minimize vulnerabilities to our borders, ports, cargo, commerce, and population and urges Congress to have the political will to fully fund Homeland Security programs relating to border security.

COL VINCENT A. GEIGER, USA (RET), AWARDED THE

"Ordre national de la Légion d'honneur"

During a 13 August 2011 ceremony, Colonel Vincent A. Geiger, USA (Ret), former commander of the General Matthew B. Ridgway-Pittsburgh Chapter of MOWW was named a Chevalier (Knight) of the French Legion of Honor.

The Legion of Honor was created by Napoleon in 1802 to acknowledge services rendered to France by



persons of great merit and is the highest award France bestows. Jean-Dominique Le Garrec, Honorary Consul of France in Pittsburgh, presented the medal.

The President of the French Republic, Nicholas Sarkozy, signed the decree on 16 May 2011. The award testifies to President Sarkozy's high esteem for COL Geiger's merits and accomplishments during World War II. In particular, it is a sign of France's true and unforgettable gratitude and appreciation for COL Geiger's and others' personal contributions to the United States' decisive role in the liberation of France during World War II.



COL Geiger is also the recipient of the Silver Star for gallantry in action when an element of Company "I," 377th, 95th Infantry Division was halted by heavy German machine gun fire near Maizures-les-Metz. Captain Geiger unhesitatingly moved to within pistol range of the German emplacement. Ignoring the sweeping enemy fire, he killed one German with small arms fire

and took nine prisoners. Later during the attack at Metz he assumed command of Company "I" at a time when fanatical opposition had caused heavy casualties. Reorganizing the company, he pressed the assault vigorously, personally leading his company in the seizure of 150 prisoners.

Sharing in his honor were members of his MOWW chapter and members of his American Legion Post, together with family members and friends. ★



The Legion of Honour, i.e., the National Order of the Legion of Honour (French: Ordre national de la Légion d'honneur) is a French order established by Napoleon Bonaparte, First Consul of the First Republic, on 19 May 1802. The Order is the highest decoration in France and is divided into five various degrees: Chevalier (Knight), Officier (Officer), Commandeur (Commander), Grand Officier (Grand Officer) and Grand Croix (Grand Cross).

In the French Revolution all French orders of chivalry were abolished. It was the wish of Napoleon Bonaparte, the First Consul and de facto sole ruler, to create a reward to commend civilians and soldiers and from this wish was instituted a Légion d'Honneur, which was a recognition of merit.

Napoleon, as emperor, always wore the cross and Grand Eagle of the Légion d'Honneur. The Légion was loosely patterned after a Roman Legion, with legionaries, officers, commanders, regional "cohorts" and a grand council.

The order was the first modern order of merit. The orders of the monarchy were often limited to Roman Catholics and all knights had to be noblemen. The military decorations were the perks of the officers. The Légion, however, was open to men of all ranks and professions. Only merit or bravery counted. The new legionnaire had to be sworn in the Légion.



What'd You Say

ne in 10 Americans has a hearing loss that affects their ability to understand normal speech. Age-related hearing loss, the most common cause of this condition, is more prevalent than hearing loss caused by excessive noise exposure. High fevers (e.g., the really high ones such as those that accompany meningitis) can result in permanent hearing loss. In fact, high fevers account for about 1,200-1,800 cases of hearing loss in the US each year.



To better avoid hearing loss, one needs to know a bit about the ear. The ear actually has three main parts: the outer, middle, and inner ears. The outer ear (the part you can see) opens into the ear canal. The eardrum separates the ear canal from the middle ear. Small bones in the middle ear help transfer sound vibrations to the inner ear. Here, the vibrations become nerve impulses, which the brain interprets as music, a slamming door, a voice, etc.

When noise is too loud, it begins to kill the nerve endings in the inner ear. As the number of nerve endings decreases, so does your hearing. There is no way to restore life to dead nerve endings. The damage is permanent. The longer you are exposed to a loud noise, the more damaging it may be. Also, the closer you are to the source of intense noise, the more damaging

Exposure to "everyday noises" can damage hearing, e.g., high-decibel noises from traffic, power lawn motors, hair dryers (85-90) and loud music (110). In fact, ambulance sirens (at 120 decibels) can cause injury, while watching jets take off and being near rocket launches without hearing protection (140-180) can cause pain. The good news is such hearing loss is avoidable. Check the industrial noises levels to which you are exposed. Testing can show the kind of damage that is present, e.g., nerve damage, and vibrating or bone conduction damage. Treatment varies with causes and degree of loss.

Some medications may contribute to hearing loss (or equilibrium issues). Ask your doctor about the antibiotics you are taking. (Gentamicin and certain chemotherapeutic agents are culprits. These aminoglycosides are toxic to the sensory cells of the ear, but they vary greatly in their relative effects on hearing versus balance.) Tinnitus (i.e., ringing in the ears) can be caused by aspirin and anti-inflammatory drugs, or just getting older. Recently, I asked an ENT doctor about the over-the-counter Tinnitus "cures." He said, "Don't you think we'd let you know if any of them worked and if there was an easy way to cure this annoyance?" Good point.

Doctors believe that heredity and chronic exposure to loud noises are the main factors that contribute to hearing loss over time. Other factors, such as earwax blockage, can also prevent your ears from conducting sounds as well as they should. Hearing loss treatments range from removing wax build-up or middle ear fluid collections in so-called conductive loss to various kinds of hearing aids to amplify sounds. An implant to the Cochlear for severe hearing loss is also possible. Ear plugs, other ear protection and sound-dampening headphones may help as well.

While ten percent of Americans experience hearing loss, the gradual hearing loss that occurs as a person ages (presbycusis) is common. According to the National Institutes of Health, approximately onethird of Americans between the ages of 65 and 75, and close to one-half of those older than 75, have some degree of hearing loss.


The key to protecting your hearing is having regular examinations and testing by your medical practitioners, and avoiding loud or prolonged noise. Early detection of a minor hearing loss is more easily treated. As a rule of thumb, if you can carry on a normal conversation without difficulty your hearing is likely adequate. Where noise cannot be avoided, use hearing protection. Additionally, there are a number tips to enhance hearing, e.g., look at the speaker, choose a quiet place to talk and have a one-on-one conversations. Looking at the speaker positions the Pinna (collecting outer ear shell) in a better position to hear and enables you to lip read at the same

The bottom line: See your doctor as soon as you notice any loss in hearing-and ask questions and read labels! ★



VA Approves Sarasota National Cemetery Enhancement

The Department of Veterans Affairs, National Cemetery Administration has approved the design of a \$5.5 million ceremonial enhancement area at Sarasota National Cemetery. The Patterson Foundation is funding the enhancement to be used for ceremonies and celebrations.



When complete, the nearly two-acre enhancement area will provide space for ceremonies and celebrations held at the Cemetery.

"This is the first time a private foundation is funding such a ceremonial enhancement," said Debra Jacobs, President and CEO of The Patterson Foundation. In January 2010, The Patterson Foundation announced a military initiative, benefiting Sarasota National cemetery. "This special gift will provide veterans and their families with a first-class facility and serve as a lasting legacy of the Patterson family's military heritage," added US Rep. Vern Buchanan, who spoke at the announcement event. "I applaud The Patterson Foundation and the VA for working together on this innovative project to honor area veterans."

Bill Introduced to Improve Security at VA Medical Centers



US Reps. Tom Rooney (FL-16) and Ted Deutch (FL-19) recently introduced legislation to enhance security at Department of Veterans Affairs medi-

cal centers by standardizing active shooter training for law enforcement personnel tasked with facility security.

The Rooney Bill directs the VA Secretary to develop policies to ensure that law enforcement officers at VA medical centers receive active shooter training consistent with the training programs established by civilian police agencies outside the centers. The legislation follows recommendations in the Department of Defense Document titled, "Protecting the Force: Lessons from Fort Hood."

"Right now, there are no standardized programs to train VA security personnel to deal with an active shooter situation. This bill addresses that security gap by requiring law enforcement officers at VA medical centers to be trained in an active shooter situation to find the shooter, engage them, and end the shooting," Rooney said. "Medical facilities, which are ill-equipped to deal with an attack, are especially vulnerable, and VA hospitals are a prime target for violence since they are dedicated to the care of our men and women who have served overseas.

DoD Re-evaluating Retirement Determinations for Some Veterans



The DoD Physical Disability Board of Review (PDBR) is re-Medical evaluating Evaluation Board (MEB) and Physical

Evaluation Board (PEB) disability ratings

for some veterans medically separated between September 11, 2001, and December 31, 2009, to ensure a correct disability retirement determination was made.

Veterans who received a combined disability rating of 20 percent or less and were not found eligible for retirement can apply to have their MEB/PEB disability rating reviewed for fairness, consistency, and accuracy. Former reserve members with greater than 20 years of total federal military service but fewer than 20 years of active duty, who meet the above criteria, are also eligible to apply. In more than half of the cases reviewed by the PDBR (as of April 2011), the applicant's Military Service Department has found the applicant eligible for a disability retirement and has awarded this to the applicant. 


